The first fruits of Dr. Williams' inspired proposal will be realized on MONDAY, JULY 4, when Arizona SENATOR JOHN McCAIN delivers the BRITISH BROADCASTING CORPORATION'S inaugural ALISTAIR COOKE ME-MORIAL LECTURE at DARTMOUTH HOUSE in Mayfair. This gathering will be hosted by the ESU, with its International Chairman, Lord Watson of Richmond, its Director-General, Valerie Mitchell, and its Washington DC Area Branch Executive Director, John Andrews, on hand for the proceedings. Others to take part in the ceremony will include Mr. Cooke's daughter and literary executor, Susan Cooke Kittredge, his biographer, BBC RADIO 4's Nick Clarke (who presides over The World at One each weekday), and BBC Director-General Mark Thompson. Senator McCain's topic will be An American Patriot Today, and we're told that he is preparing some declarations of interdependence for the occasion. His lecture will be recorded, and if all goes well it will soon be available in both audio and video formats. Recent Highlights

AMBASSADOR AND LADY MANNING HOST A JOYOUS BRITISH EMBASSY RECEPTION

It was **Tuesday evening**, **May 3**, and once again the heavens graced a memorable gathering with a clement-weather emergency. For those who enjoyed sitting or strolling in a garden that has become justly proverbial for its flora, the azaleas and dogwoods blossomed in full profusion. For those who savored an



enticing selection of hors d'oeuvres with the beverages of their choice, a friendly retinue of waiters seemed ever at the ready. What made the festivities particularly special, however, was the warmth with which HER MAJESTY'S AMBASSADOR AND

LADY MANNING paid tribute to the reception's honorees and welcomed approximately 230 **ESU** constituents and their guests to the Mannings' beautiful residence in the **BRITISH EMBASSY**.

The only disappointment in an otherwise perfect occasion was that three venerable leaders, Richard H. Howland, Priscilla Liggett, and Eleanor Ritchie, who were being recognized for their distinguished contributions to the ENGLISH-SPEAKING UNION and to a number of other worthy causes, were too frail to attend. Their presence was nevertheless palpable as Sir David Manning and ESU President Frederic W. Schwartz, Jr., thanked them for all they'd achieved during their more active days.

Sir David recalled, for instance, that all three had been significantly involved in the **ESU**'s commissioning of a magnificent statue of **SIR WINSTON CHURCHILL**, which had been installed in front of the gates at 3100 Massachusetts Avenue NW and dedicated on April 9, 1966. Conceived by **Alexander C. Liggett**, and

sculpted by William M. McVey in collaboration with landscape architect Fred S. Toguchi, this monument had been designed so that "one foot stands on United States soil, one on British Embassy grounds: a symbol of Churchill's Anglo-American descent, and of the Alliance he did so much to forge, in war and in peace."



As Sir David addressed the values we indelibly associate with this unique statesman, he went on to commend the special relationship that Churchill's legacy epitomizes, a topic that prompted him to reflect, not only upon the many ways in which the U.K. and the U.S. continue to build fruitfully upon a broad spectrum of shared traditions, frameworks, and institutions, but upon the accelerating global proliferation of a language that undergirds so much of our cultural and political heritage.

In reply to Sir David's generous remarks, **ESU** branch President **Frederic Schwartz** thanked him, his charming Lady, and Social Secretary **Amanda Downes** for all they'd done as hosts of an

evening to cherish. He went on to acknowledge several underwriters, among them the MORRIS AND GWENDOLYN CAFRITZ FOUNDATION for major program support, Marjorie J. Williams and Walter L. Wright III for their sponsorship of key endeavors, and the BRITISH-AMERICAN BUSINESS ASSOCIATION for its assistance to the



ESU fellowship fund. He then enumerated five recipients of recent laurels from the ENGLISH-SPEAKING UNION, among them the winner of our *SHAKESPEARE TEACHER AWARD* for 2005 (Jennifer Hoover of BETHESDA - CHEVY CHASE HIGH SCHOOL in Montgomery County, Maryland), the top contestant in our *SHAKESPEARE COMPETITION FOR THE NATIONAL CAPITAL REGION* (Emily Matich, a student of Lisa Coyne at OAKCREST SCHOOL in McLean, Virginia), the designee of our *WALTER L. WRIGHT III AWARD FOR EXCEPTIONAL PROMISE IN THE DRA*



MATIC PROFESSION (Elizabeth Webster of the ACADEMY FOR CLASSICAL ACTING at THE SHAKESPEARE THEATRE), and the

new holders of two HELENE GLAD-STONE WILLIAMS AWARDS, Colette Crossman, a Ph.D. candidate in art history at the University of Maryland, who will be in Great Britain this summer conducting research in London, Oxford, and other locales on spiritual themes in the works of Victorian painter Edward Burne-Jones, and the Rev. Nathan J. A. Humphrey, a scholarly Epispocal curate in Monkton, Maryland, who will be enrolling shortly in a doctoral program at St. John's College in the University of Cambridge.

NEW OFFICERS AND DIRECTORS ELECTED AT ESU'S ANNUAL GENERAL MEETING

Owing to the kindness of Executive Director John Churchill, and thanks to the helpfulness of his staff at the PHI BETA KAPPA SOCIETY, from whom the ENGLISH-SPEAKING UNION now rents office space, the Nation's Capital branch of the ESU held its ANNUAL GENERAL MEETING FOR 2005 in a Victorian mansion that houses one of America's most prestigious organizations.

This get-together, which attracted 36 attendees, began at 10:30 a.m. on Saturday, May 21, at 1606 New Hampshire Avenue NW. After the formal proceedings, which lasted an hour and a half, those who could stay and mingle for awhile were treated to a light buffet luncheon, catered by Diana and Peter Nicholson.

The primary purpose of the event was to review the branch's accomplishments over the last twelve months, outline plans for the year ahead, and elect directors and officers to fill several slots that were to become available on June 1. A NOMINATING COMMITTEE, headed by Patricia Plaskett and including A. Graham Down, Ian McDonald, Lee Viccellio, and Sarah Williams, presented a slate that elicited unanimous approval when voted upon by the membership. As a consequence Gerald B. Kauvar,

who had served for a year as First Vice President, succeeded Frederic W. Schwartz, Jr., as President, Thomas M. Pazzi became the new First Vice President, and Braxton Moncure accepted another term as Treasurer. Also re-elected were five Vice Presidents: Armida Colt, Macauley Howard, Eleanor Ritchie, Marjorie J. Williams, and Mark Wyatt. One new Director, D. Elizabeth Crompton, had agreed to complete the last two years of a 3-year term from June 2004 through May 2007. Meanwhile the Board benefited from the accession of four new Directors for 3-year terms from June 2005 through May 2008: Stephen F. Black, James C. Ledyard, Mark Olshaker, and Jeanne A. Roberts. Finally, the membership approved a 2005-6 NOMINATING COMMITTEE that will consist of Stephen F. Black, Ian McDonald (Chair), Diana Nicholson, Lee Viccellio, and Sarah Williams.

Frederic Schwartz thanked everyone who had contributed to his term as President. He extended best wishes to Gerry Kauvar, and he voiced confidence that Mr. Kauvar would build effectively upon the foundation he'd done so much to establish through his efforts on the EDUCATION and GOALS & STRATEGY

committees. In response Mr. Kauvar expressed deep gratitude and presented Mr. Schwartz, as a gift from his fellow officers and directors, an inscribed copy of the book that accompanied a December 2004 program, co-sponsored by the ESU, that had featured a preview of Robert MacNeil's PBS series Do You Speak American?



Mr. Kauvar (here pictured in conversation with Treasurer Braxton Moncure at the May 3 BRITISH EMBASSY reception) went on to say that he looked forward to doing all he could to get more of the membership vigorously involved in branch activities. He described 2004-5 as a "strenuous year." He made it clear, however, that he did not regard the ENGLISH-SPEAKING UNION as a "fragile organization." He embraced its "global mission" as an important one, and he spoke enthusiastically about the ESU's future.

The reports that accompanied the main business of the session were generally upbeat. Executive Director John Andrews observed that the branch had offered an unprecedented number of program attractions (30) in 2004-5, eight more than in 2003-4 and twice as many as in 2002-3. He noted that these events had taken place in a diversity of locales, among them the AMERICAN ARCHITECTURAL INSTITUTE, AMERICAN UNIVERSITY, the BRITISH EMBASSY, the CORCORAN GALLERY OF ART, DACOR BACON HOUSE, the EISENHOWER INSTITUTE, the MANSION ON O STREET, the NATIONAL GALLERY OF ART, the NATIONAL PRESS CLUB, the NATIONAL TRUST FOR HISTORIC PRESERVATION, the NEW ZEALAND EMBASSY, WASHINGTON NATIONAL CATHEDRAL, and the WOMAN'S NATIONAL DEMOCRATIC CLUB.

Mr. Andrews emphasized that almost all of these gatherings had been presented in collaboration with other organizations, and he supplied a partial list that included the AUSTRALIA AMERICA ASSOCIATION, the BRITISH-AMERICAN BUSINESS ASSOCIATION, the BRITISH COUNCIL, CANTABDC (a local group for graduates of the University of Cambridge), the CATHEDRAL CHORAL SOCIETY, the HARVARD CLUB OF WASHINGTON, the LONDON SCHOOL OF ECONOMICS' ALUMNI ASSOCIATION, MACNEIL/LEHRER PRODUCTIONS, the NEWSEUM, POLITICS & PROSE, the PRINCETON CLUB OF WASHINGTON, and WETA TELEVISION.

He also distributed a packet of *ESU Program HighLights* that illustrated how consistently publicized these events had been. One, a luncheon presentation by Sir Harold Evans to highlight his PBS series *They Made America*, had been televised several times over C-SPAN2's weekend *BOOKTV* service. And many of the others had been featured in such media outlets as the *City Paper*, the *Georgetowner*, the *Washington Examiner*, and the *Washington Post* (in *Book World*'s Literary Calendar, in the *Sunday Source* section, and in Jane Horwitz's *Backstage* column), not to mention the bulletins, brochures, and printed invitations of cooperating institutions. As a consequence, he said, these events were appealing to constituents who'd had no previous awareness of the ENGLISH-SPEAKING UNION, and many of them were becoming regular attendees and joining the ESU.

Mr. Andrews' comments were strongly reinforced by a PROGRAM COMMITTEE report from co-chair Celia Josephs, who singled out a number of her favorite moments: a mid-September luncheon with Princess Michael of Kent, focusing on her novel about two ancestors who had been rivals for the love of a Renaissance king; a late-September dinner with media personalities Robert Aubry Davis, Martin Goldsmith, and Larry Kane, who reminded us about the Beatles' first visits to America in 1964; Corcoran dialogues in October, November, February, and March with actor F. Murray Abraham, New Yorker columnist Adam Gopnik, Washington Post critic Peter Marks, and actress Lynn Redgrave and her daughter Annabel Clark; a late-November chat about Shakespeare's sonnets with Renaissance scholars Paul Edmondson and Stanley Wells; a December concert by the world-renowned Choir of King's College, Cambridge; luncheon talks in January and March by authors Stephen Greenblatt (Will in the World) and Michael W. Kauffman (American Brutus); a mid-February lecture about William Pitt the Younger by William Hague, former Leader of Britain's Conservative Party; a late-March dinner gathering about "The Rise and Rise of English" with Lord Watson of Richmond, ESU's International Chairman; a mid-April dinner conversation about David Garrick's Clandestine Marriage with London director Richard Clifford, Folger Theatre producer Janet Griffin, and actors Catherine Flye and Ted van Griethuysen; a late-April gathering (one of three in association with the ROYAL OAK FOUNDATION) at which British historian John Wilton-Ely extolled the virtues of Horace Walpole as a "Mirror of the Georgian Age"; an early-May book-signing with Ernestine Bradley, who talked about growing up in Nazi Germany and eventually making her way to the United States as an airline stewardess; and two recent midday presentations by prominent ESU members, Barrett McGurn, who spoke about his role as editor of Yank magazine during World War II, and Judith Farr, who discussed the most recent of her four books about poet Emily Dickinson. Mrs. Joseph praised her colleagues on the committee for all their help, particularly co-chair Tom Pazzi, who was unable to attend the Annual General Meeting. She lauded Audrey Pendergast for her efforts in arranging a mid-May tour

of Italian Renaissance masterpieces at the NATIONAL GALLERY OF ART. And she thanked Graham Down, Braxton Moncure, and Jane Plakias for making their homes available for receptions, holiday parties, picnics, and other get-togethers.

Commenting on the **ESU**'s fiscal condition, Treasurer **Braxton Moncure** noted that, although the branch appeared likely to finish the 2003-4 fiscal year with a deficit of nearly \$17,000, more than half of that figure was offset by a \$9,801 surplus that had been carried over from the previous cycle. He pointed out that over a 6-year period since mid-1999 the surpluses had usually come at opportune times, often from legacies bequeathed by long-time **ESU** members, and that as a result the average deficit was only \$4,982. "If we're going broke," he smiled, "we're doing so very slowly." Referring everyone to a page labeled Balance Sheet, he noted that the branch now enjoys \$273,788 in Current Assets, \$256,055 of which is invested in Endowment funds.

Mr. Moncure went on to observe that the Current Assets category no longer includes a \$335,000 "Deed of Trust" that had been carried on the branch's books until recently. As he and Mr. Schwartz explained, this sum had represented a mortgage the ESU once held for a former clubhouse at 2131 S Street NW, a property which had been sold to a couple who required supplemental financing to afford some long-overdue renovations. Sadly, before they could complete all their work on the building, the new owners had been forced into bankruptcy and foreclosure. In the aftermath of this unsettling development, owing to a bizarre chain of events that included a bold act of theft by one claimant to the property, the ENGLISH-SPEAKING UNION had been thwarted in its attempts to collect the unpaid balance on its loan. Mr. Schwartz emphasized that he was continuing to represent the ESU on a pro-bono basis and had filed an appeal in the case. Because he now estimated the branch's odds of success at less than 50%, however, he had advised the board to remove this figure from the Balance Sheet as an Asset. This step had been reported to, and approved by, the National Office, and through them, Mr. Schwartz observed, it would also be reported to such external authorities as the Internal Revenue Service.

Speaking in his role as Chairman of the EDUCATION COMMIT-TEE, A. Graham Down described 2004-5 as a "challenging year." He noted, for example, that the annual SHAKESPEARE COMPETITION had had to be rescheduled twice because of winter-weather advisories that closed area schools. Chuckling over the ESU's uncanny talent for generating snow on demand, he said, one teacher had gone so far as to suggest a new sideline for the branch as a proprieter of ski resorts. Despite these difficulties, however, the March 4 contest drew even more students to the Lansburgh theater than had its predecessor in 2004. The contest itself had been excellent as usual, and the only negative thing that could be said about it was that, for the first time in more than a decade in a half, none of the entrants represented a public school from the District of Columbia. Mr. Down said that through the good offices of Stephen Black, a Committee member who also serves on the board of THE SHAKESPEARE THEATRE, the ESU would be coordinating with David Snider, who heads the Theatre's Text Alive program and works regularly with DC teachers and students, to address that problem. Mr. Down went on to observe that the Committee would be

doing what it could to strengthen the area's middle-school competition, now in its second year as a collaborative effort with the UNIVERSITY OF MARYLAND'S CENTER FOR RENAISSANCE AND BAROQUE STUDIES, and that it would be exploring ways to be more helpful to teachers like Fran Caterini of WASHINGTON EPISCOPAL SCHOOL, who helped found the new contest and who is now seeking to develop a new Shakespeare curriculum for her institution that would provide a logical sequence of readings and activities for grades seven through twelve.

ENGLISH IN ACTION Director Diana Nicholson reported that EIA continues to attract volunteers to an endeavor which assists newcomers with the subtleties of a language whose nuances are unfamiliar to them. She pointed out that current tutees hail from locales as far-flung as Bolivia, Brazil, China, Colombia, El Salvador, Eritrea, Ethiopia, France, Hungary, Iran, Ivory Coast, Japan, Mexico, Nicaragua, Paraguay, Peru, Poland, Romania, Russia, Spain, Sri Lanka, Sudan, Taiwan, and Yemen. She was also happy to say that adults in need of tutoring are regularly referred to her by the D.C. PUBLIC LIBRARY RESOURCES DIVISION, by the PAN AMERICAN HEALTH ORGANIZATION, and by other institutions. Mrs. Nicholson thanked Executive Director John Andrews for his assistance in updating the program's database, and she said that the latest figures indicate that roughly 140 tutors and tutees are regularly participating in EIA activities. She articulated her gratitude to the loyal members of her committee - George Desorcy, Rachel Hecht, Phillip Miller, Sorab Modi, Audrey Pendergast, Madelyn Ribnick, and Sarah Williams - and on behalf of them she thanked such stalwart supporters of ENGLISH IN ACTION as Graham Down, Braxton Moncure, Jane Plimpton Plakias, and Eleanor Ritchie, each of whom has hosted one or more EIA functions.

To conclude the proceedings, Frederic Schwartz called upon Sally Stokes, recipient of a 2004 HELENE GLADSTONE WILLIAMS AWARD, for some comments about the use to which she had put her \$4,000 in



ESU grant funds. Ms. Stokes delivered a touching, witty, and beautifully illustrated presentation, beginning with an endearing account of her initial awareness of **Noel Streatfeild**, a recent British writer whose life and work she had been studying for the last several years, and proceeding to a detailed narrative about the sites she had visited, the libraries and archives she had consulted, and the friends, relatives, and descendants of the author

who had welcomed her into their homes, replied to her inquiries, provided her with introductions, and given her access to any materials in their possession that might be pertinent to the publications and lectures she was expecting to produce. Among other things, Ms. Stokes talked about her desire to secure new, and more perceptive, generations of readers for classics such as Ballet Shoes. As she drew her remarks to a close and found herself greeted with applause, it was obvious that she had succeeded with at least one audience. Everyone agreed with Mr. Schwartz's observation that Ms. Stokes' report – like the research she had conducted and was continuing to augment as she learned more about her subject had been a model of the kind. Among the attendees who concurred with this assessment was the Rev. Nathan J. A. Humphrey, who will probably be addressing a similar group of ESU members a year hence as he pursues his doctorate at the University of Cambridge.
